TERMS AND CONDITIONS

1. The contract would run from _____ through _____.
2. Hours of operations: To be determined according to the ballfield schedule.
3. All equipment, food and necessary licenses must be provided by Permit holder.
4. In the event that any law now existing or which hereafter may be passed by any lawful authority, County, Federal or State, shall require the payment of any license fees, taxes or other charges on account of the use of operation of said equipment, said charges shall be paid by the Permit holder.
5. Upon execution of this contract, the Permit holder shall make a flat fee payment of _____ payable to M-NCPPC. Failure to do so will be cause for immediate revocation of this contract.
6. The Permit holder may only operate at the specific facilities reserved on the permit contract.
7. The Permit holder will provide trash cans adjacent to the snack cart. These trash cans must be emptied and all trash removed at the end of each day.
8. The Permit holder must furnish the Commission with a copy of their current Maryland State Sales and use Tax License and their Food Service Facility License issued by Montgomery County Government, Department of Health and Human Services. Both of these documents shall be incorporated as Attachments to this contract.

Additionally, the Permit holder agrees to comply with the following:

1. No beer or alcohol allowed.
2. Follow all rules and regulations stated on the permit and any other requirements deemed necessary by M-NCPPC.
3. Furnish the Commission with a copy of a current Maryland State Sales and Use Tax License and a Food Service Facility License issued by Montgomery County Government, Department of Health and Human Services. Both of these documents shall be incorporated as Attachments to this contract.
4. Provide a valid certificate of liability insurance written by a carrier licensed to write insurance in the state of Maryland with limits of \$500,000.00 per person and \$1,000,000.00 per accident or injury incurred.
5. The above named Permit holder is responsible for any necessary cleaning and trash removal resulting from the delivery of vendor's products. All trash must be removed from the park site.
6. Two-thirds of the attendees must be residents of Montgomery or Prince George's County, MD.
